Premier League Funding

In Edition 1 of "Membership Matters" we announced the renewal of Premier League funding for one further season to support U11 District rep football: those of you who are eligible to apply for this funding (in effect, affiliated Districts running U11 teams) were emailed about this and so just a quick reminder that the closing dates for expressions of interest for funding is 19th October.

We are starting the planning for the national finals which will, as previously indicated, run in a similar format to the 15/16 season but will include a girls' event too. The national finals will be preceded by regional events once again, and although we appreciate the relative short notice of these fixtures, we hope that you will be able to take part. With the exception of the Midlands, regional tournament dates have been set for:

Saturday 21st January – North (venue tbc)
Saturday 4th February – South West (venue tbc)
Saturday 18th February – South East (venue tbc)

Refereeing

A couple of developments from the FA:

Firstly, in a letter to CFAs, following discussions about the draft National Referee Strategy, The FA has said:

"In light of {this} feedback, the FA Referees' Committee has decided not to proceed with the amalgamation of Levels 6 and 7 into Level 5. However, for Season 2017/18 we will proceed with the change of name of Levels 8, 9 and 10 which will become:

- Level Y Youth Referee (formerly Level 8)
- Level T Trainee Referee (formerly Level 9)
- Level D Referee Developer (formerly Level 10)

An aspect of the proposals which was supported was the importance of allowing those referees (regardless of age) with talent to move quickly (but not too quickly!) through the refereeing Levels. Consequently, we will propose a change to the Referees Regulations to allow CFAs to review the performance of Level 6 and 7 referees during December of each year and, where a referee is showing real promise and ability, the CFA can promote them as from 1 January. Such a change would enable us to retain the 'faster movement' through the system which was a key part of the proposals relating to Levels 5, 6 and 7."

Secondly, an instruction has been sent to CFAs to support CSFAs and DSFAs to identify qualified referees wishing to officiate in ESFA activities, by sending lists of those officials to Association secretaries. We appreciate that, in many areas of the country, the appointment of suitably qualified officials is unproblematic but where it is more challenging, the support of the CFA may be helpful.


Child Welfare Compliance and Association Suspension

- We receive a lot of enquiries regarding girls and boys playing in the same fixture. Mixed football is permitted up to and including the Under 18 age group
- Schools and clubs can apply for funding to replace unsafe goalposts. Details can be found under the "funding schemes" tab at www.footballfoundation.org.uk
